

.xn--5tzm5g (.web, .网站)– Terms and Conditions

In addition to your registration agreement, the .xn--5tzm5g(.web, .网站) Registry-Registrar Agreement (“**RRA**”) terms and conditions set out here shall apply. In the event of any inconsistency between the terms of your registration agreement and the terms set out here, the RRA terms shall prevail.

1. Registered Name Holder to indemnify, defend and hold harmless GWTA and its subcontractors, and the directors, officers, employees, affiliates and agents of each of them, from and against any and all claims, damages, liabilities, costs and expenses, including reasonable legal fees and expenses, arising out of or relating to the Registered Name Holder's domain name registration. The registration agreement shall further require that this indemnification obligation survive the termination or expiration of the registration agreement.
2. Registered Name Holder, shall be obligated and comply with each of the following requirements:
 - a. ICANN standards, policies, procedures, and practices as may be adopted or amended from time to time;
 - b. operational standards, policies, procedures, and practices for the Registry TLD established from time to time by GWTA in a non-arbitrary manner and applicable to all registrars, including affiliates of GWTA, and consistent with ICANN's standards, policies, procedures, and practices and the Registry Agreement. Additional or revised GWTA operational standards, policies, procedures, and practices for the Registry TLD shall be effective upon thirty days notice by GWTA to Registrar. If there is a discrepancy between the terms required by this Agreement and the terms of the Registrar's registration agreement, the terms of this Agreement shall supercede those of the Registrar's registration agreement; and
 - c. public interest commitments (as set forth in Specification 11 to the Registry Agreement, as amended from time to time), community registration policies (if applicable, as set forth in Specification 12 to the Registry Agreement, as amended from time to time) and Government Advisory Committee (“**GAC**”) safeguards (as set forth in Exhibit B to this Agreement or otherwise published or provided to Registrar by GWTA from time to time).
3. Additionally Registered Name Holder agrees to:
 - a. consent to the use, copying, distribution, publication, modification and other processing of Registered Name Holder's Personal Data by GWTA and its designees and agents in a manner consistent with the purposes specified pursuant to this Agreement
 - b. submit to proceedings commenced under ICANN's Uniform Domain Name Dispute Resolution Policy (“**UDRP**”) and/or Uniform Rapid Suspension (“**URS**”); and
 - c. immediately correct and update the registration information for the Registered Name during the registration term for the Registered Name;

- d. agree to be bound by the terms and conditions of the initial launch of the Registry TLD as published by GWTA from time to time, including without limitation any sunrise period, limited registration period, or land rush period, and the dispute resolution policies and rights protection mechanisms mandated by ICANN or GWTA for the TLD (including without limitation the Trademark Clearinghouse), and further to acknowledge that GWTA has no liability of any kind for any loss or liability resulting from the proceedings and processes relating to the sunrise period, limited registration period, land rush period or other period associated with the initial launch of the Registry TLD, including, without limitation: (a) the ability or inability of a registrant to obtain a Registered Name during these periods, and (b) the results of any dispute resolution process regarding a registration; and

- e. acknowledge and agree that GWTA reserves the right to deny, cancel or transfer any registration or transaction, or place any domain name(s) on registry lock, hold or similar status, that it deems necessary, in its discretion; (1) to protect the integrity and stability of the registry; (2) to comply with any applicable laws, government rules or requirements, requests of law enforcement, or any dispute resolution process; (3) to avoid any liability, civil or criminal, on the part of GWTA, as well as its affiliates, subsidiaries, officers, directors, and employees; (4) per the terms of the registration agreement; (5) for the non-payment of fees by Registrar, including without limitation pursuant to the terms of any Credit Facility or (6) to correct mistakes made by GWTA or any Registrar in connection with a domain name registration. GWTA also reserves the right to place upon registry lock, hold or similar status a domain name during resolution of a dispute.
